I oppose the proposal. I have serious concerns about multiple aspects including potential adverse effects on natural values such as biodiversity, flora and fauna, the adjacent wetlands, Lake Mahinapua and the potential for contaminants realeased to land and water as a result of operations. Furthermore, this is a fledgling industry on the Coast with many unknowns.
Mineral sands mining is touted as an economic 'saviour' for the Coast but again there have been problems already with WMS with the Mananui barge running aground, and mineral concentrate blowing around the streets of Westport during a storm. Mining has traditionally been a 'boom and bust industry.
I also have concerns about the quality if life of local residents and road safety; with and addition of big new industry and processing, mining and trucking operation operating 24/7. Visiting tourists could also be adversely affected by this.
This operation does not have to be so close to the wetlands. There are only 10% wetlands left in NZ and crucial to the wellbeing of the ecosystems on which all life depends. These bottom lines should be thoroughly investigated before proposals which tout economic prosperity are considered.
